#### **ORDER**

Information & Public Relations Department, Govt. of Kerala have invited applications from professional agencies/persons for preparing an empanelled list of agencies for making creatives for various campaign activities of the Department on behalf of Government of Kerala. As per the Government Order read as first paper above, agencies/persons were empanelled earlier under three categories for a period of 3 years, which was later extended as per the Government Order read as 4th paper above.

As per the notification read as 2nd paper above, applications were called for from the experienced agencies/persons for empanelment under the following two categories:

Category A – Television/ Theatre/ Social Media / Radio Creatives Category B – Print / Outdoor Creatives

The applications received within the prescribed time limit were evaluated by the Selection Committee constituted as per the proceedings read as 3rd paper above. After examining the presentation of various agencies /persons, the Committee submitted its recommendations vide note referred as 5th paper above.

The Government have examined the matter in detail and are pleased to empanel agencies/persons as detailed below for making creatives under the following two categories for a period of 3 years from the date of this Order.

The terms and guidelines for the empanelled agencies / persons are as follows:

- (1) The agencies/persons shall provide their dedicated services to the Department as and when necessary and shall complete each work within the time limit prescribed by the Department.
- (2) Agencies/persons empanelled under Category 'A' should submit, on requisition proposal for creatives of Television/Theatre show, Animation, Short Films and Radio creatives with concept and storyboard. The budget / estimate for the proposal should be submitted in a separately sealed envelope. The budget for the selected proposal will be finalized after negotiation with the concerned agency/person and the final payment will be made only after the evaluation by the cost committee.
- (3) Content oriented posters, brochures, creatives for newspaper ad/outdoor ad, infographics and motion graphics should be prepared and submitted as per the Department's requirements. The budget / estimate for the creative should be submitted in a separately sealed envelope. The budget for the selected proposal will be finalized after negotiation with the concerned agency/person. The final payment will be made only after the evaluation by the cost committee.
- (4) The maximum payment that the department may grand for each type of creative will be informed prior to the submission of proposals. The amount already approved for various creatives will remain the same.
- (5) Creatives in Malayalam, English and Hindi should be submitted by the empanelled agencies / persons within the time stipulated.

(6) Those agencies/persons who do not participate in the campaigns conducted by the Information & Public Relations Department continuously without any valid reason will be eliminated from the panel without any prior notice.
