- 3. A discount of 15% in the advertisement rates shall be charged from all empanelled theatre agencies.
- 4. The empanelled theatre agencies is eligible for getting Goods and Service tax applicable from time to time.
- 5. The Advertisement rate will stand force from the date of Rate Contract signed between the two parties and will remain until the new Government Order in this regard comes into force.
